

## *The Symbol of the Unicorn*

# Who is the Tribe of Manasseh?

Bible prophecy speaks directly of the United States of America and Great Britain in our day. Prophecy reveals we are largely descended from the ancient tribe of Joseph, the first-born son of Jacob by his wife Rachel.. Our national greatness was prophesied. But Joseph had two sons, Ephraim and Manasseh. Which modern nation is descended from Ephraim, and which from Manasseh? Who is really who?

In the book of Genesis we read the astounding statement, and prophecy, made by God to Abraham and his descendants:

"By myself have I sworn, saith the LORD, for because thou hast done this thing, and hast not withheld thy son, thine only son: That in blessing I will bless thee, and in multiplying I will multiply thy seed as the stars of heaven, and as the sand which is upon the sea shore; and *thy seed shall POSSESS THE GATE OF HIS ENEMIES*; and in thy seed shall all the nations of the earth be blessed; because thou hast obeyed my voice" (Gen.22:16-18).

This prophecy was later repeated to Rebekah by her brothers, who said to her when she accepted the proposal of marriage on Isaac's behalf made by Abraham's servant:

"And they blessed Rebekah, and said unto her, Thou art our sister, be thou the mother of thousands of millions [literally, billions], and *let thy seed possess the gate of those which hate them*" (Gen.24:60).

One of the most important, astonishing truths of Biblical prophecy is that the Anglo-Saxon people -- the founders of the United Kingdom, and the United States of America -- are descended from ancient Abraham, Isaac, and Jacob. Our forefathers are

descended from the fabled "Lost Ten Tribes" of ancient Israel. One of the vital proofs of this is the fact that our nations have possessed the strategic sea gates around the world, just as the Scriptures foretold thousands of years ago! My book *America and Great Britain – Our Identity Revealed: Ephraim and Manasseh in the End of Days* clearly proves the modern day identities of our nations.

Many Biblical prophecies speak of the fate of the leading nation of "Israel" during the last days -- that is, the United States of America. In Bible prophecy, we are the tribe of "Ephraim," the leading birthright tribe, the younger of the two sons of Joseph. God inspired the patriarch Jacob to prophesy of the two brothers, Ephraim and Manasseh: "The Angel which redeemed me from all evil, bless the lads; and let my name be named on them, and the name of my fathers Abraham and Isaac; and let them grow into a *multitude in the midst of the earth*" (Gen.47:16). Jacob later said that Manasseh would be "great," but added, "but truly his younger brother shall be *greater than he*, and his seed shall become a *multitude of nations [or, states]*" (v.19).

Ephraim was set before or above Manasseh in rank and power and blessing. They were to become a "multitude of STATES," as the original Hebrew says -- and truly the "*United STATES of America*," comprised of FIFTY SOVEREIGN, INDIVIDUAL STATES, *fulfills this prophecy to the "T"!*

### ***Blessings of the USA***

Ephraim was to become a united company or assembly of peoples. Isn't it interesting that the United States is famous around the world for being the "melting pot" of the nations? The United States has more emigrants from more diverse locations, than any other nation on earth! This is both a strength, and a fatal weakness. The prophet Hosea foretold this condition would describe Ephraim in the last days! Hosea wrote, "Ephraim MIXES with the nations; Ephraim is a flat cake not turned over [white on one side, baked black or brown on the other side!]. Foreigners sap his strength, but he does not realize it. His hair is sprinkled with gray, but he does not notice" (Hosea 7:8-9).

The United States began with thirteen colonies, and a flag of thirteen stripes and thirteen stars. Ephraim was the "thirteenth tribe" of ancient Israel! Mere coincidence?

Ephraim's very name means "double fruit." It is the United States which exploded onto the world scene, becoming a world power in the days of Theodore Roosevelt at the turn of the century, and the twentieth century has been hailed as "America's Century," and world peace "Pax Americana."

In a very short time, historically speaking, the United States grew, burgeoned, with rippling muscles, and grew past his older brother Manasseh, yet they are united by language and cultural ties unlike that of any other separate nations on the face of the earth! They are true brothers, sometimes arguing, squabbling, fighting, but back-to-back against any common enemy from the outside!

### *The Greatness of Ephraim*

Jacob prophesied that the younger brother, Ephraim, was to be greater than his older brother, Manasseh. Manasseh, the firstborn, was the older brother. Which nation is older -- the United States or Great Britain? That fact alone should tell us that Great Britain was the older brother, Manasseh, which was to be "great," and even has the word "great" in its name, unlike any other country on the earth today!

But what about the United States? Is it greater than Great Britain, even as Ephraim was to be greater than Manasseh?

Let's face this question honestly and squarely, without pride, pretense, or hypocrisy. The United States is the wealthiest nation in the world in terms of resources, business and assets, and gross national produce -- although we have also become the world's biggest debtor nation by far due to our sins and living beyond our means during the past decade. We comprise only six percent of the world's population, and yet we control over 40 percent of the world's wealth!

When Jacob, or Israel, blessed Joseph's two sons, Ephraim and Manasseh, he knew what he was doing. He deliberately blessed the YOUNGER son with the primogenital blessing of the firstborn, making him the son of the right hand. The older son, Manasseh, shared in the blessing -- but a double portion went to Ephraim! When Joseph protested this sudden switch from the expected, saying that Manasseh was the firstborn, Israel refused to change the blessing, and said:

"I know it, my son, I know it: he also shall become a people, and he ALSO shall be GREAT: but truly *his YOUNGER BROTHER shall be GREATER THAN HE, and his seed shall become a MULTITUDE of nations.* And he blessed them that day, saying, In thee shall Israel bless, saying, God make thee as Ephraim and as Manasseh: and he set *Ephraim before Manasseh*" (Gen.48:19-20).

Let us notice two things about this verse -- this prophetic blessing. The younger brother, born last, would rise up and become greater than the older brother, in time. The older would also become great -- but not as great as the younger!

Of those who understand the basic rudiments of this prophecy, the majority of people, influenced by British-Israelism, believe or have assumed that the British represent the people of Ephraim, and the Americans or "Yanks" the descendants of Manasseh. But is this true? Or has national pride and prejudice caused men to mix up the two boys, or peoples, as Joseph thought Israel had done? Is there in actual fact a parallel here, and the two peoples have been mixed up and mis-identified by the majority who have studied the subject?

### *Who Was to be the Greatest?*

Notice carefully the verses we just covered, once again. Manasseh was prophesied to become GREAT. The British people, today, are known as GREAT Britain.

They have truly been a great nation, in history, forging the links of a mighty empire, which formerly it was boasted that the sun did not set on the British Empire -- it was global in extent. However, Britain is not so great and powerful today. It has a population of about 57,000,000.

On the other hand, Ephraim was prophesied to become "a multitude of nations." The Jewish Tanakh has this: "Yet his younger brother shall be greater than he, and his offspring shall be *plentiful enough for nations.*" Compared to the British, the population of the United States of America, which was a paltry few millions in 1776, today stands at 256,000,000 -- over four times the population of Great Britain!

The British *never became* a "*multitude of nations.*" This prophecy did not state that Ephraim would "RULE" a multitude of nations, but that he would "BECOME" a multitude of "nations." If you count all the Anglo-Saxon members of the British Commonwealth, you have only five nations, most of them with very small populations -- Canada, the largest, population 27,000,000, followed by Australia, 17 million, New Zealand, 3,400,000, and South Africa, where the predominant population is black.

The Hebrew word for "multitude" in this verse is #4393 in Strong's Exhaustive Concordance. It is *melo* and literally means "fullness," or "full." *Gesenius Hebrew-Chaldee Lexicon* explains it as "fullness, hence that which is full," as "fullness of hands," "a basin full of water." It also means "a multitude, crowd."

The Hebrew word translated "nations" here is actually *goy*, which is the Hebrew word for "Gentile," also. The plural, *goyim*, can mean "nations, Gentiles," "a troop," in the sense of *massing*, "a flight of birds," "a flight of locusts," "a troop of animals," etc. It is variously translated "Gentile, nation, heathen, people."

Carefully looking at these definitions, then, we see there is no proof in this verse whatsoever that The British Commonwealth are Ephraim, and that Manasseh is the United States. Rather, the FULLNESS OF PEOPLES dwells in the United States -- 256 million, to be exact! *Gesenius* defines *goy*, "a people, a confluence of men," and adds: "Prop. it would seem *body, corpus*, from the root [*gah*] which see; and then transferred to a *body politic*, or whole people." In other words, it could also be translated as "STATES" -- as in "*united STATES of America*"!

The *United States* of America fit this description, or definition, perfectly. America is a union of FIFTY STATES, comprised of many different peoples from different racial stocks, but primarily northern European and Anglo-Saxon.

### ***"A Nation and a Company of Nations"***

The Hebrew word for "company" is *qahal* and means "assemblage, congregation, multitude." "An assembly, a crowd of nations," says *Gesenius Hebrew-Chaldee Lexicon to the Old Testament*. Historically speaking, the one nation of Israel, which ruled the effective world, or at least dominated the world and world trade during the reign of Solomon, split into two kingdoms following his death. Ten tribes -- a "company" of

nations, led by the tribe of Joseph -- split off from the kingdom of Judah, composed of the tribe of Judah, Benjamin and Levi.

The "Northern Kingdom" of Israel, under Jeroboam, quickly slipped into paganism, and transgressed the laws of God. The Israelitish kings wanted nothing to do with the religion of Judah, the Jews, lest the heart of the people turn once again to the kingdom of David. So Jeroboam established his own pagan priests, who taught a mixture of Torah truth with a blend of pagan sacerdotalism. His kingdom embraced the ways of Baalism, and forsook the truth of God. Therefore, after warnings from prophets and holy men of God, including Elijah, God finally sent the northern kingdom into exile at the hands of the Assyrians in 718-721 B.C.

The northern ten tribed kingdom was broken up, and carried off into exile. "And the LORD rejected ALL the seed of Israel, and afflicted them, and delivered them into the hand of spoilers, until he had cast them out of his sight. For he rent Israel from the house of David" (vs.20-21). Because of their idolatry, "the LORD removed them out of his sight. . . So was Israel carried away out of their own land to Assyria unto this day" (v.23).

Altogether there were undoubtedly millions in this composite mass Exodus out of the promised land to the region of the Caucasus. They remained in servitude essentially until the collapse of the Assyrian Empire in 612 B.C. After this, they formed great nations of peoples in the Caucasus, Iranian plateau, and north of the Black Sea and in Eastern Europe and southeastern Asia. After Alexander the Great conquered the Persian Empire in 334-331 B.C., the tribes of Israel -- after having been sold into captivity 390 years earlier (Ezek.4:1-5) -- were released, and free to begin their migrations and treks across the landscape of Asia and Europe to their eventual destinations -- the shores of western and northern Europe, and the British Isles! They became known to history as the Celts, Cimmerians, as part of the larger mass of peoples called the "Scythians." The very name "Scot" comes from "Scyth" In Hebrew "ska" or "ski" means "a sharp weapon, a knife." It is related to the word "sku" for "hill, "watchtower," and also to the word for "intellect, understanding, the heart, the mind." The Scots, of course, are noted for their agility of mind and quick-wittedness and mental brilliance and clarity.

In Genesis 35:11 God told Jacob that his progeny would become "a nation and a community of nations." Notice which came first -- the single nation. Then the community of nations, or "united states," were to follow. Again, this is exactly what history records. The single nation -- Great Britain -- came first historically and was great, and Britain "ruled the waves," the British pound was the international currency, and the "sun never set" on the British Empire.

But then the "company of nations" or "united states" followed, and surpassed the greatness of the British Empire at its height. After World War II, no nation and no empire could compete with the UNITED STATES OF AMERICA! It ruled the sea lanes of the world; its currency, the dollar, was the foundation of international trade. Thus Ephraim, the United States, surpassed his older brother, Manasseh, or Great Britain.

It was all prophesied long ago!

### ***Population Explosion!***

One of the tremendous blessings God promised the descendants of Israel in the end-times was great fertility and fruitfulness, the blessings of the womb (Gen.17:6, 22:17, Deut.28:4). Jacob referred to Joseph as a "fruitful vine near a spring, whose branches climb over a wall" (Gen.49:22). The descendants of Israel in the End Time were to be "as the sand of the sea" (Isa.10:22). "Who can count the dust of Jacob, or number the fourth part of Israel?" (Numbers 23:10).

Fruitfulness, flourishing population, can also refer to the *rate* of growth. The growth rate of the United States has been nothing short of phenomenal -- from virtually nothing to 240 million in only 200 years! During that time Britain has grown from 15 million to 60 million -- four times. But the United States has grown from a population of 3,240,000 in 1784 to 300,000,000 in the same length of time -- an exponential population growth of nearly *70 times over!* No country in history has, like the United States, literally come from out of nowhere, and literally EXPLODED in population growth and power, both military and economic!

Truly, the United States -- modern "Ephraim" -- has experienced a dramatic population increase. Truly it has lived up to its name -- and is "DOUBLY fruitful"!

### ***End-Time Greatness***

In another passage, Moses was inspired to prophecy of these two brothers, together making up the tribe of "Joseph," their father, and which became the two individual sub-tribes of Ephraim and Manasseh,

"His glory is like the firstling of his bullock, and his horns are like the horns of unicorns: with them he [Joseph, both tribes together] shall PUSH *the people together to the ENDS OF THE EARTH:* and they are the *TEN THOUSANDS OF EPHRAIM, and they are the THOUSANDS OF MANASSEH*" (Deut.33:17).

Notice! It was Ephraim which was to outnumber Manasseh in population by something like a ratio of TEN TO ONE! Now consider! Which nation, today, is the larger of the Anglo-Saxon nations? Which has the most power? Which has the greatest natural resources and blessings? England? Or the United States of America? As we have already noted, the population of the United States, at 250,000,000, far exceeds that of Great Britain at 57,000,000, or that of Canada at 27,000,000. Furthermore, it was the United States which "saved the bacon," as it were, of the English and Western Europeans during World War I, and especially World War II! In this end-time generation, it is the "Yanks" who are by far the "greatest" military power among the sons of Jacob!

In ancient times, the tribe of Manasseh was itself divided into two half tribes -- one located EAST of the Jordan river, in Palestine, and one WEST of the Jordan river, and just NORTH of the Tribe of Ephraim. Interestingly, in modern times this same geographic juxtaposition has been maintained by the descendants of these ancient tribes. Today, Manasseh -- represented by England (east of the body of water we call the Atlantic Ocean), and Canada (west of that body of water) -- still lies NORTH of Ephraim, the United States of America!

Despite the obvious evidence that America fulfills the prophecies concerning the tribe of Ephraim, there is another very significant proof that Great Britain and Canada are primarily descended from the tribe of Manasseh.

### *Manasseh's Identifying Marker*

There is a tribal identification marker which reveals which modern day nations are descended from the ancient Israelite tribe of Manasseh and which are descended from his brother Ephraim.

Ephraim and Manasseh were the two sons of Joseph. They were numbered among the tribes of Israel and were to be the recipients of great national and natural blessings. But how can we determine which nation comes from which tribe? Some argue that the U.S.A. is Manasseh, and that the British Commonwealth is Ephraim.

However, there is a clear SYMBOL which reveals the identity of Manasseh – no doubt about it!

What is that sign? It is the sign of the “unicorn.”

### *The Symbol of the Unicorn*

Moses prophesied of Joseph in Deuteronomy 33: “His glory is like a firstborn *bull*, and his horns like the horns of a *wild ox*; together with them he shall push the peoples to the ends of the earth; they are the ten thousands of Ephraim, and they are the thousands of Manasseh” (Deut.33:17, NKJV). The King James Version has this verse, “His glory is like the firstling of his *bullock*, and his horns are like the horns of *unicorns*” (first part). The Hebrew word *reem* can be translated either “wild ox” or “unicorn,” from the word *raam*, “to be lifted up” (i.e., the horns).

The glory of Joseph is likened to that of a “bull.” The Hebrew word is *showr* and means “bullock, bull, cow, ox.”

Can the United States be compared to a “bull”? Absolutely! The United States is the greatest cattle raising country in the world. It is only fitting that the symbol of ancient Ephraim, the bull, would apply to the U.S. More than a fourth of the land area of the U.S. is used for grazing and pasture. Dairy and beef cattle are the most important livestock raised on American farms. Farms in the Midwest and enormous ranches in the

West raise most of the beef cattle. In sheer numbers, the United States's cattle industry overwhelms that of all other nations. In 1985 all cattle in the U.S. totaled 109,582,000. U.S. beef production in the year 2000 was 26,888,000,000 pounds. No other country even comes close! Cattle and ranching play a very important role in American history, especially the conquest of the "Wild West." The American cowboy and longhorn cattle are the stuff of legend.

In its relations with other nations, the United States can also be aptly compared to a "bull," which likes to shove its weight around. It is not ferocious like a "lion," or quick as a lion, but when it gets its act together, it can marshal immense strength – just like a "bull."

### *The Unicorn*

The "unicorn" is a mysterious creature which has fascinated mankind and captured its imagination. What was the "unicorn"? It is somewhat of a mystery, even today.

On the one hand, says *Peloubet's Bible Dictionary*, "Unicorn, the rendering of the Authorized Version of the Hebrew *reem*, a word which occurs seven times in the Old Testament, as the name of some large wild animal. The *reem* of the Hebrew Bible, however, has nothing to do with the one-horned animal of the Greek and Roman writers, as is evident from Deut.33:17, where, in the blessing of Joseph, it is said, 'His glory is like the firstling of his bullock, and his horns are like the horns of a unicorn;' not as the text of the Authorized Version renders it, 'the horns of *unicorns*.' The two horns of the *reem* are 'the ten thousands of Ephraim and the thousands of Manasseh'" (p.714).

Says Peloubet, "Considering that the *reem* is spoken of as a two-horned animal of great strength and ferocity, that it was evidently well known and often seen by the Jews, that it is mentioned as an animal fit for sacrificial purposes, and that it is frequently associated with bulls and oxen, we think there can be no doubt that some species of wild ox is intended. . . It is probable that it was the gigantic *Bos primigenius*, or aurochs, now extinct, but of which Caesar says, 'These uri are scarcely less than elephants in size, but in their nature, color and form are bulls. Great is their strength and great their speed; they spare neither man nor beast when once they have caught sight of them'" (*ibid.*).

Gesenius, however, says this animal is "a wild animal, fierce and untamed, resembling an ox, as a wild ass resembles an ass . . . possessed of horns with which it prostrates everything . . ." (p.751). He identifies it with the *buffalo*. On the other hand, he points out that the Arabic word which answers to this denotes the *oryx*, a large and fierce species of *antelope*. Interestingly, Arabs call wild animals of the *deer* kind *wild bulls*.

The *Encyclopedia Britannica*, eleventh edition, describes the "unicorn" as "a fabulous beast, usually having the body and head of a horse, the hind legs of an antelope, the tail of a lion (sometimes horse's tail), sometimes the beard of a goat, and as its chief

feature a long, sharp, twisted horn, similar to a narwhal's tusk, set in the middle of its forehead." It points out that ancient historians took the unicorn seriously and described it in their histories. "The earliest description is that of Ctesius, who states that there were in India white wild asses celebrated for their fleetness of foot, having *on the forehead a horn a cubit and a half in length*, colored white, red and black." It continues, "Aristotle mentions two one-horned animals, the oryx, a kind of antelope, and 'the so-called Indian ass.' In Roman times, Pliny mentions the oryx, the Indian ass, and an Indian ox as one-horned; Aelian, quoting Ctesius, adds that India produces also a one-horned horse. . . . Strabo says that in India there were *one horned horses with stag-like heads*" (*Encyclopedia Britannica*, "unicorn," 11<sup>th</sup> edition, vol.27, p.581).

How does the "unicorn" become involved in the question of the identity of Ephraim and Manasseh?

### *The STANDARD of Manasseh*

In his books on the Lost Ten Tribes, and Ephraim and Manasseh in particular, Yair Davidy points out that *the ancient sign or symbol of the tribe of Manasseh was the "unicorn."*

Let's take a look at the "unicorn" as it refers to modern nations and their national symbols and identities. As we have already taken notice, prominently on the Royal Coat of Arms of the United Kingdom, or Great Britain, there is a rampant lion, and a unicorn standing on its hind feet.

Yair Davidy, in his book *The Tribes: The Israelite Origins of Western Peoples*, explains:

"A lion represents the kingdom of David and Judah. Moses (Deut.33:17) *compared Joseph to a bull and to a unicorn*. In the blessing of Balaam the strength of all Israel is compared to that of a *unicorn* (Num.23:22). A UNICORN (Raem) was represented on the STANDARD OF MANASSEH *son of Joseph, according to the MIDRASH*" (Yair Davidy, *The Tribes*, p.220, second edition, Russell-Davis Publishers, Israel, 1999).

Read that candid admission once again! Davidy confesses that the "unicorn" was the emblem or sign of THE TRIBE OF MANASSEH! Therefore, we should expect the "unicorn" to be prominent among and identified with the tribe of Manasseh! This fact should be obvious to anybody with an open mind. F

So where do we find the "unicorn" prominently displayed, today? Where do we find the "unicorn" symbol among the nations of the world? It is incorporated into the Royal Coat of Arms of England, Scotland and Northern Ireland – the UNITED KINGDOM! The unicorn is featured prominently on the ROYAL SEAL of GREAT BRITAIN!

*The very Seal of the Royal Coat of Arms of Great Britain BEARS THE IDENTIFYING SIGN of the Israelite tribe of MANASSEH!*

In other words, the symbol of ancient Manasseh, as Rabbis point out, was the unicorn. A “unicorn” was “a fabulous animal generally depicted with the body and head of a horse, the hind legs of a stag, the tail of a lion, and a single horn in the middle of the forehead” (*Webster’s Dictionary*). If the unicorn was the sign of the tribe of Manasseh, then this sign or identifying symbol should follow the people of the tribe of Manasseh, and should be an excellent means to *identify* who are the people of Manasseh!

What people on the earth – what nation or nations – have the “unicorn” as their national symbol?

*Scotland’s Royal Coat of Arms*



The Royal Coat of Arms of Scotland, shown above, has two unicorns, on the left and right of the shield with a lion, and a crown above the shield.

### *“Unicorns Everywhere”*

The “unicorn” is found virtually everywhere, throughout the length and breadth of Great Britain – in public buildings, libraries, offices, the courts, in the Anglican churches (Church of England), government buildings, parliament, throughout the British Isles.

But on the other hand, you don’t find the sign of the unicorn anywhere in the United States, as an official symbol of anything. It is not on public buildings, not in churches, courts, or government offices. It is simply missing. It has no real significance to Americans!

This great contrast should tell us something. It should *prove beyond doubt* to us that Manasseh, with its sign of the unicorn, is found today in GREAT BRITAIN, where the unicorn is found in prolific abundance!

The ancient emblem of the unicorn is *only* found on the Royal Coat of Arms of Great Britain, Scotland and Canada! The Royal Coat of Arms of Scotland has TWO unicorns! On the other hand, the Unicorn is *not* a part of any American national symbol or standard, and is *not* connected with the United States.

If America were indeed “Manasseh,” how did we lose our own national historic standard, the symbol of the “unicorn”? And why and how did it gravitate to our “brother” Ephraim instead? Why would “Ephraim” have the standard which identifies *Manasseh*?

Yair Davidy writes in an article entitled “The Unicorn,” in his magazine *Brit-Am Truth*, issue no.7, on page 19, published in 2004, the following:

“The unicorn was originally the symbol of Scotland. The Coat of arms of Scotland bears two unicorns. When Scotland was unified with England the unicorn (together with the lion) became a symbol of Britain. The word for Unicorn in Hebrew is ‘raem.’ ‘Unicorn’ really is a legitimate translation of ‘raem.’ *Only Britain has the unicorn as an official symbol. This alone is worth considering.* The unicorn became the emblem of Scotland: the Scottish coat of arms has two unicorns. When Scotland united with England the lion and the unicorn were together on the British coat of arms. The Midrash says that ‘raem’ (unicorn) was the symbol of **MANASSEH**. [This is *his own emphasis!*] In our passage [Deut.33:17] Israel is likened to a unicorn. *Only in Britain does the unicorn appear as a national symbol.* On the other hand the unicorn came to Britain from Scotland which is still represented by two unicorns.”

### *The Unicorn Sign of Great Britain*

Yair Davidy confesses, “When Scotland united with England the lion and the unicorn were together on the British coat of arms. The Midrash says that ‘raem’ (unicorn) was the symbol of **MANASSEH**. [This is *his own emphasis!*] In our passage [Deut.33:17] Israel is likened to a unicorn. *Only in Britain does the unicorn appear as a*

*national symbol.* On the other hand the unicorn came to Britain from Scotland which is still represented by two unicorns.”

Did you get that? “Only in Britain does the unicorn appear as a national symbol”!

Isn’t that a remarkable admission! He states plainly that the unicorn is a symbol of Manasseh. In fact, he highlights the word “Manasseh” in *bold capital letters*. He admits that **ONLY BRITAIN** has the unicorn as a “national symbol” and an “official symbol.” He even says, “*This alone is worth considering.*”

Yes, it most certainly IS worth considering!

How simple! *Q.E.D. (quo erat demonstrandum)* – that which was to be demonstrated has now been done. I suggest that this proves the identity of Manasseh, End of argument. The solution is plain. The case is closed. The identity is proven.



The Royal Coat of Arms of the United Kingdom – the official Coat of Arms of Great Britain and Northern Ireland – shows a crown resting on a shield. The shield is quartered, depicting in the first and third quarters the three lions passant guardian of

England; in the second quarter is the rampant lion of Scotland; and in the third quarter the harp for Northern Ireland.

The crest at the top is a lion statant guardant wearing the imperial crown. The right supporter is a likewise crowned lion, symbolizing England; on the left is a unicorn, symbolizing Scotland. The unicorn is chained, because in Medieval times a free unicorn was considered very dangerous – it was believed that only a virgin could tame a unicorn.

The Coat of Arms features the motto of the British monarchs – “Dieu et mon droit” – “God and my [birth] right.”

For use in Scotland, the Queen has a separate Coat of Arms. In this Coat of Arms, quarters one and four of the shield are Scotland; quarter two is England; and quarter four (the harp) is Northern Ireland. The supporters also change sides, and the unicorn is on the right side and is imperially crowned, and the rampant lion is on the lefthand side. At the crown, a Scottish red lion holding a sword and a sceptre sits on a crown. At the bottom is the motto, “Nemo me impune lacessit” – “No one provokes me with impunity.”

The Royal Arms of Scotland features on both the right hand and left hand sides a rampant crowned unicorn, with a red lion on the shield. The Royal Arms *for* Scotland differs, and has a rampant lion on the left and a rampant unicorn on the right hand side; its shield is quartered like the Royal Coat of Arms for the United Kingdom. Since the uniting of the crowns of Scotland and England in 1603, the Arms of the King of Scots have been incorporated into the versions of the Royal Coat of Arms of the United Kingdom.

### ***Q.E.D.***

On the other hand, Yair Davidy writes, “More than 80% of the founding settlers of the USA came from Scotland *and related areas* in the North and West of Britain” (*ibid.*). Since the emblem of these areas was the unicorn, Mr. Davidy thinks this means that the “unicorn” people are the ones who settled in the United States. Does this make sense?

If indeed many U.S. settlers came from the north and west of Britain, would that mean that they constitute Manasseh? Not at all! How can this be explained?

Perhaps the precise opposite is true. That is, those people who *left* those areas do so because they did not FIT IN with the Manassites who dominated that region. They did not fit in under the sway of Manassites, and because they were of *Ephraim*, they picked up and departed from areas controlled by Manasseh, and immigrated to the American colonies! In other words, they left because they were NOT of Manasseh. But for a while, the two peoples dwelt together in the British Isles, out of necessity. Once the opportunity availed itself, however, they took advantage of it and struck out on their own for distant lands and shores.

You see? The fact that those who came to America left the region dominated by Manasseh doesn't prove they were Manassites, but quite the opposite! The Ephraimites among them didn't enjoy living under *Manasseh's* local, entrenched government in Scotland and western Britain. So, for this reason they left – migrated – to the Western Hemisphere to set up their *own government!*

If those people who left, to come to the United States, were Manassites, as Yair believes, then it would stand to reason that they would have TAKEN THEIR HISTORIC EMBLEM AND SYMBOL OF THE UNICORN *WITH THEM!*

But they did not do this.

*There are no unicorn symbols in America. Yet they are spread out all over the British Isles and the United Kingdom. Doesn't this fact tell us anything?*

It should be ringing like the Liberty Bell, ringing out the news, that America is not Manasseh, but the United Kingdom *is* the people of Manasseh, because it has the symbol of Manasseh – the unicorn – *virtually EVERYWHERE!*

The symbol of the unicorn stayed where the people of the unicorn stayed.

The evidence of which nations possess the UNICORN in their standard or Royal Coat of Arms is very important – and it is very indicative of who is really who!

The emblem of the unicorn itself *identifies* Scotland, England and Canada as being none other than the descendants of the ancient tribe of MANASSEH! Therefore, since *Great Britain, Scotland and Canada are the only nations in the world that have the UNICORN as their national symbol*, that fact *identifies them* as being, in the aggregate, the modern-day tribe of *Manasseh*.

Yair Davidy also wrote in “Brit-Am Now”-#392, sent out to his mailing list April 26, 2004, “The unicorn became the emblem of Scotland: the Scottish coat of arms has two unicorns. When Scotland united with England the lion and the unicorn were together on the British coat of arms. The Midrash says that the ‘raem’ (unicorn) was the symbol of Manasseh. . . . *Only in Britain does the unicorn appear as a national symbol.*”

The *Canadian* Coat of Arms also bears the same unicorn emblem. It, too, has a rampant lion on the right-hand side of the coat of arms, and a standing unicorn on the left. Therefore, it, too, stands identified by its emblem as a modern descendant of MANASSEH!

Remember, ancient Manasseh was divided into two parts – one settled east of the Jordan River, and one settled west of the Jordan River, bounded on the west by the Mediterranean Sea. In a similar manner, modern Manasseh is also divided into two parts

– separated by a body of water – the Atlantic Ocean. The eastern part is the United Kingdom (Great Britain) and the western division is Canada.

Since Canada has the unicorn as a symbol in its Royal Coat of Arms, and since the unicorn is a symbol of ancient Manasseh, this clearly identifies Canada as being also primarily descended from ancient Manasseh.

The symbol of the “unicorn” is one of the great incisive proofs that Canada and Great Britain are descended from Manasseh.

### *It's Time to Admit the Truth*

What does all this tell us? What does this evidence prove? The sign of the unicorn is *proof positive* to anyone with a truly open mind that GREAT BRITAIN and CANADA are primarily descended from ancient MANASSEH!

If Great Britain were truly Ephraim, then why does their Royal Standard bear the clear representation of the Unicorn – the symbol or sign of the tribe of Manasseh? The Unicorn of Great Britain identifies the British as primarily of the tribe of Manasseh. And if the unicorn is the symbol of Manasseh and the United States is “Manasseh” – why doesn't the United States have this symbol in their national emblems and symbols?

Why, indeed! It would appear to be nothing more than a “curious conceit” to claim that Great Britain is the tribe of Ephraim when its very symbol the “unicorn” identifies it and stamps it on its very forehead as being the tribe of Manasseh.
